January 30, 2022 - Annual Meeting Minutes

Held in conjunction with Worship

The Zoom Worship Service began at 10 a.m. with the Welcome and Orientation for the combined Worship/Meeting and Gathering Music, which fittingly recognized that "The Church is More Than Just a Building."

Call to Order: at 10:08 a.m. by Hariph Smith, Moderator

Moderator's remarks: Hariph offered his appreciation for the congregation's generosity this past year, both for the church and for its missions. He ruefully noted that he had hoped 2021 would be a better year than 2020 as far as covid was concerned but that it did not work out that way; he offered renewed hope for improvement in 2022.

Attendees: 27 covenant members were present, exceeding the minimum requirement of 20 for a quorum. Also attending were 1 associate and 4 parish members.

Elections:

Carol Whitter, representing the nominating committee, offered many thanks to those retiring from their years of service in long-held roles:

- Cyndi Hall as Clerk
- Doug Whittier as Financial Secretary and Investment Committee
- Sharon Coulton as Deacon
- Carol Ellingwood as Trustee
- Ann Mitchell as Council Member at Large and Delegate

The congregation voted to accept the complete 2022 Slate of Officers, Boards and Committees presented in the annual report booklet and as amended during the meeting (to add Dina Blodgett as new Council Member at Large, and Delegate to the Living Waters Association and ME Conference Annual Meeting.) Motion was made by Ginger Smith and seconded by Wendy Dennis.

The Nomination Committee presented the Slate of Officers, Boards and Committees as follows:

<u>Church Officers</u> – Hariph Smith will continue as Moderator and Ginger Smith will continue as Treasurer. New church officers for 2022 are Sharon Coulton as Clerk and Cyndi Hall as Financial Secretary.

<u>Board of Deacons</u> – Rebecca Lazure, Dana Hall, Jeff Dennis, and Jennifer Phillips will continue as Deacons while Maryelise Lamet was nominated to cover Sharon Coulton's unfinished term; one position remains vacant.

<u>Board of Trustees</u> – Mike Mayette, Connie Mayette, Tom Irwin, and Luke Lazure will remain as Trustees; Gwen Gruver was nominated as new board member.

<u>Board of Church & Community Concerns</u> – All members will continue in 2022: Wendy Dennis, Lee Gilman, Penny Pray, Susan Mauro, and Kate Goodspeed.

<u>Board of Christian Education</u>: All members will continue in 2022: Jill Halligan, Kristin McLaren, Carol Whittier, and Lee Wise; one position remains vacant.

<u>Investment Committee</u>: Alan Elllingwood and Peter Coulton will remain on the committee in 2022; one position is now vacant.

Memorial Funds: Ann Mitchell will continue in this capacity in 2022.

<u>Council Member at Large</u>: Wendy Dennis and Lee Gilman will continue in 2022; Dina Blodgett was nominated as a new member.

<u>Delegates to Living Water Association and Maine Conference Annual Meeting:</u> Cyndi Hall and Sandra Smith remain for 2022; Dina Blodgett was nominated as a new Delegate.

<u>Nominating Committee</u>: Marlene Douglas and Carol Whittier were nominated to continue on this committee. One position remains vacant.

Opening Prayer: Pastor Intern Sarah Mills led those assembled in prayer.

Scripture Reading: Ephesians 3:1-6 read by Maryelise Lamet

<u>Sermon</u>: Co-Inheritors of the Promise. Pastor Chrissy's homily included an insightful comparison between the actions of birds in a "murmuration" and the church: individual beings motivated (by faith) to work together (for the gospel); joining together responsively by intention, paying attention to one another, and moving together toward a shared goal.

<u>Prayers were offered by each of the Boards</u> for the ongoing work of our church and the efforts of its many servants, followed by prayer requests from members of the congregation and The Lord's Prayer. Many thanks were offered for all the work that has been done to keep us together while we are unable to gather in person, and particularly the creativity in the use of Zoom and PowerPoint.

<u>Treasurer's Remarks</u> – Ginger Smith noted how difficult it was for the Trustees to project how the church would fare financially when preparing the budget for 2021. She was thankful to report that we did have a great year, much better than expected due to a number of unforeseen blessings. She noted that the 2021 budget had anticipated a deficit of \$6,178, but we closed with a positive cash flow of \$16,254 that allowed a transfer of \$12,400 to savings. This was mostly attributed to:

- Loose offerings were more than \$4,000 above the budgeted amount.
- Summer Fair, which was unplanned and unbudgeted, brought in about \$3,000.
- Kate's quilts, which brought in an additional \$839 over what was sold at the Fair.

- Investment income, which was about \$9,000 above budget due to timing; two years of payments were received in 2021.
- CARES Act payments of \$3,200 that were not budgeted for partial reimbursement of salaries during COVID

Ginger stated we have a great financial picture at the end of 2021 in spite of Covid and everything else. She also offered thanks to Doug Whittier for all the guidance and wisdom he shared with her over the years for fulfilling the role of Treasurer.

Board of Church and Community Concerns remarks and Call to Offering: Wendy Dennis also commented on what a gratifying year it turned out to be and noted that the collection of more than \$2,000 for OGHS was outstanding. She also offered thanks to Kate Goodspeed for leading the stewardship campaign and referenced 2nd Corinthians 9:7 in noting there is no pressure or compulsion here. Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver. You must each decide in your heart how much to give.

Prayer of Dedication for the offering

<u>Vote on Written Annual Reports:</u> The members voted to accept the Annual Reports as written, upon a motion by Mike Mayette, seconded by Dana Hall. There was no discussion of the individual reports.

Transitional hymn

<u>Discussion of the Proposed 2022 Budget:</u> Mike Mayette prefaced the budget discussion by noting that last year the Trustees proposed a deficit budget which ended up in a surplus due to a lot of favorable, unexpected circumstances. He stated another deficit budget is being proposed and noted the following:

- Expectations for income from investments was increased, due to several years of overperformance in this area.
- Anticipated income from fundraising is estimated at \$6640, with the hope that we have more opportunities for fundraising events in 2022 than 2021.
- Wage increases for employees followed the standard COLA. (Although a bonus for Chrissy was contemplated in appreciation for all her effort, it was decided we could not include one this year.)
- Increased expenses for our internet upgrade, increase in electricity rates, rising insurance premium on the building (up 20%) and rapidly rising fuel costs. Ginger noted that the cost for oil delivery this month was \$1500.
- Custodial budget this year is for 12 months, whereas last year only 6 months was budgeted, and noted that the contractor has indicated their rate is going up. Additionally, it does not include the chapel wing or the Fellowship Hall.
- The suggested budget does not include a music director until later in the year, hoping we can have more of a music presence by that time. This could be included earlier in the year with an increase in the deficit, and is an item offered for discussion for the church to decide.

Budget Discussion:

There was some discussion of Pastor Chrissy's compensation, with an explanation of how it is structured between salary and housing. Kate Goodspeed also suggested that in the future we consider increasing the amount allotted for Our Church's Wider Mission. The bulk of the discussion centered on the proposed funding for Music Director.

The proposed budget included \$1600 for a substitute organist playing twice a month through August and starting with a music director in September for 3 Sundays a month plus weekly choir rehearsal. Dana noted we have the opportunity to secure Rosalea again as Music Director and she is willing to do 3 Sundays beginning in September. Chrissy advised that we should plan for anyone, and not limit ourselves if Rosalea happens to be less available when we are able to expand.

Doug proposed that we budget to fund the Music Director position beginning in February instead of September to re-invigorate the in-person music program. He stated that it could be funded out of the 2021 surplus.

Hariph pointed out that the Council hasn't voted to meet in person in February. (Due to the surge in Covid cases, the church reverted to all Zoom worship beginning in January.) He stated that those are separate decisions to put the funding in the budget versus when we actually implement it.

Wendy did not have a recommendation but felt it is okay to pay less until the choir is able to start up. She noted that the Council was willing to fund it and had already increased the fundraising somewhat already in the proposed budget in order to increase the coverage for music that was suggested. This was a commitment to have special fundraising when it is safe to expand activities. She said the Council was unable to predict if the congregation would be willing to put it in the budget now. She noted that church leadership understands this is an important issue, and that it has received significant discussion prior to this point.

Jeff added that even if we are not able to sing or play in the sanctuary, we can record. He noted that having a music director to help coordinate this activity would be helpful. More of that could happen even while we are meeting purely remotely or hybrid. There would be more opportunity for members to create music so there is value in having the position even if we can't yet have live music in the church. Chrissy noted it would be beneficial to her to have a music director selecting and preparing the music that is used for services.

After revised numbers were calculated by Ginger, Doug motioned to increase the funding for music director at \$7700 beginning in February; seconded by Jen Phillips. It was noted this would increase the budget deficit from the proposed -\$5,535 to -\$10,195; the vote was unanimous to accept this change.

Voting on the overall budget: Kate moved to accept the budget as modified, seconded by Doug. The motion passed without further discussion.

As the last order of business, Nancy moved to adjourn the meeting, seconded by Kate. The motion passed, and the meeting was adjourned at 12:30 p.m.

Audit Report

I have audited the records and the financial reports of the Winthrop Congregational Church UCC dated December 31, 2022 and contained herein. In my opinion, the financial reports mentioned above are fairly stated.

Investment Committee Report

The S&P 500, a barometer of the market, closed out 2022 with its worst calendar year performance since 2008, dropping 17%. Our Church portfolio value began the year at \$158,312 and finished at \$131,224, a drop of 17% as well.

The value of the portfolio is one thing, but the church takes only the dividends and capital gains, so we maintain the initial number of shares purchased. When the value of the stock drops, so does the ability of these stocks to produce a dividend, and there are no capital gains. It's been a lean year.

Bear in mind that the market is cyclical. The past history of our management of our investments has been that we have held our portfolio investments without trades for several years. Stocks are now at "bargain prices", so investing new funds at this juncture would be advisable.

Financial Secretary's Report

As Financial Secretary, I have deposited all monies received by the Winthrop Congregational Church, United Church of Christ into the church's checking account held at the Kennebec Savings Bank.

All donations made by individual contributors were recorded on a weekly receipt form, along with other monies received by the church. Since the church has a PayPal account, all donations paid through this venue were recorded and transferred to the church's checking account on a weekly basis. The weekly receipt forms list individual contributors by assigned numbers. Copies of weekly receipt forms were provided to the Treasurer along with copies of the bank deposit slips.

Separate records were kept of individual's contributions. Statements showing contributions to date were mailed out at of the end of April, August, and December. Most statements were sent by email, with only eight going through the postal service, which helped minimize costs.

This year's Stewardship Campaign theme was "From Bread and Cup to Faith and Giving". A total of 28 households responded with pledges totaling \$52,392. Thirteen pledges increased, five pledges decreased, and ten pledges remained the same. The average pledge amount increased from \$1,703.33 in 2022 to \$1,871 in 2023.

Pastor's Report

Beloveds in Christ,

This year may be known as the year Pastor Chrissy broke her ankle and dislocated her elbow just a few weeks before annual meeting. Modern technology and my generous wife are helping me complete this report in time to include it in the annual meeting booklet.

This year has been a year, at least in my mind, where we been taking stock of how we have changed as a church since the beginning of the pandemic. Not only have several beloved church members died over the last few years, but at least 15 (probably more like 18 or 19) members and regular attendees of the church have moved out of Winthrop, and several other beloved church members are no longer able to attend regularly. We have also had some newer folks who have been attending regularly. This change in who regularly shows up means that church feels different. Not bad, but different.

This significant change in regular attendance has also shifted how we are able to find volunteers. I have been grateful for the folks who have stepped into new roles where they have never served before and for those who have helped them learn those roles. We have also had new roles, like tech support, that some volunteers have stepped up to cover. That being said, some volunteer activities, like helping to open and close camp and raking the roof in snowstorms, need more hands than we've typically been able to rally. If you are looking for places to volunteer, those are two places that could use some help.

I am grateful to the Board of Church and Community Concerns for their introduction of See. Judge. Act. into our conversations around mission. Not only do I think this is a good way to direct our energies as a church, I think it gives us a way to invite people who are not currently involved in our church to work towards our mission with us. We are including the two reports from our See. Judge. Act meetings in this annual meeting booklet.

I was grateful, once again, to our church for hosting and mentoring a second student pastor from the Maine School of Ministry. Sarah Mills helped us to sing in different ways and led a couple classes on sharing our faith story. And, Buddy the dog was an excellent church greeter. Hosting students not only helps the student and the church, but also helps the Maine Conference train the next generation of Maine pastors. This is a good service our church has offered to the conference.

It was also good to welcome Rosalea and the choir back to singing and playing regularly at church. As Rosalea is only playing twice per month, we've had to be creative about how we have music weekly. Thanks to everyone who pitched in with music this year, especially the choir and bandmembers (who I asked for help at the last minute several times).

So many forces beyond our control are affecting our life as a church. Between the ongoing pandemic and an economy that often puts profit over people, we are being asked to respond to a lot of change very quickly. I believe we can, but it will take some work, discernment, and trying new things. And our work will be bolstered by the ways we can gather together in joy and gratitude over the year. I hope we can find new ways to enjoy fellowship together as well as serve our neighbors in the coming year.

Moderator's Report

Is the nature of the church I grew up in gone forever? Probably.

Will our church still be here in ten years, fifteen years...? Yes, if we want it to be.

These are difficult issues to think about. Fortunately, many folks are doing just that, including gathering data to help us determine what is going on. Today, membership in Maine UCC churches is 60% of what it was in 2008. I expect this trend to continue. The Maine Conference is actively focusing on its role going forward as its membership continues to shrink.

Faith Communities Today is a multi-faith collaborative research initiative that has been tracking trends in US congregations since 2000. It is the largest effort of its kind. In 2020, 15,278 religious communities from 80 different denominations were surveyed. For those interested, the most recent report is available on their website (https://faithcommunitiestoday.org/wp-content/uploads/2021/10/Faith-Communities-Today-2020-Summary-Report.pdf).

This most recent research shows that across all denominations, faith-based organizations are growing older, smaller and tend to be less vital. While this trend is discouraging, the research also found that some faith-based congregations are thriving. In general, these thriving congregations have:

- strong lay leadership
- a clear and compelling mission
- are innovative and open to change
- are diverse
- welcome new people
- look outward more than inward

Other studies have also looked at why some churches thrive. One attribute of many of these churches is that they are considered a key member of the local community. How does this

happen? There is a growing consensus that looking outward is important. Also important is inviting other community members to join you in whatever outward looking efforts you chose to support. Currently, younger folks tend to be less interested in joining organizations but will often support efforts to help others. Let's invite our community to join our efforts to serve. If nothing else, we may make some new friends.

So, will our church survive? I am convinced it certainly can if we want it to. However, it will take significant effort and will require all of us to think differently about what "church" is. We will not be alone in figuring this out. Research continues, success stories abound, seminars have already happened, and more are being planned. We may even host one. You will hear more about this as we start a new year. Please participate any way you are able.

Some highlights of the year:

Deacons assisted in formulation of the Church's COVID Mitigation Policy – including the use of the Green, the Yellow, and the Red Strategies.

After starting the year with ZOOM only worship services for the first six weeks, we were able to conduct Hybrid Worship Services for the rest of the year – except for a worship service led by Intern Pastor Sarah Mills in April and a worship service led by Mo Ausbrook in July.

Old South Church recorded music of members of Old South's Choir and WCC's Choir and bell ringers from both churches for use by both churches during Holy Week. We had joint Maundy Thursday and Good Friday services.

Rosalea Kimball transitioned from Church Musician to Music Director in May on a part time basis of two Sundays a month.

Another key transition this year was the resumption of singing in Church including the Choir and the Congregation.

We bid farewell to Intern Pastor Sarah Mills (and Buddy!) in May. Sarah returned to lead worship for one week in July.

Special music offerings by Glen Goff and Mel Burrowes enhanced worship in the Summer.

The Deacons resumed collecting offering on Sundays in the fall.

Pastor Becky Walker returned to lead worship in November for the first Sunday in Advent.

Christmas Eve Worship featured Lessons and Carols music by the Church Band, Autumn and Charlotte Wise, and Gaby and Alice Lazure. Ricky Phillips provided guitar music on Christmas Day.

Board of Church and Community Concerns Report

Thank you to the church congregation for generously engaging in the mission activities organized by the BCCC in 2022. Many of our projects are monetary collections because that is often the best way to provide for people in need. For example, when we give to One Great Hour of Sharing, our money is pooled with contributions from thousands of other churches and is directed to problems of severe magnitude that we would not by ourselves be able to address. Likewise, when we give to Church World Service blankets, our money buys blankets at wholesale cost and adds to supplies in storage all over the country to be tapped into at a moment's notice. It is not particularly fun for BCCC to ask for money, so we try to provide relevant educational information and personal accounts that connect us to the essence of the targeted problems. We are so grateful for your compassionate response.

International missions:

One Great Hour of Sharing

In March we promoted this multi-denominational Christian effort to support disaster relief, refugee relief, and development and empowerment projects. It resulted in WCC donating \$1,088 to OGHS in 2022.



Church World Service Blankets



In May, on Mother's Day, Kate Goodspeed displayed a quilt of colorful "mini-blankets" representing the people we honored or held dear in memory with our donations for blankets. We collected \$591 for CWS blankets.

Maine UCC missions:

Maine School of Ministry

In February we took up a collection that generated **\$348 for MESOM**, recognizing how fortunate we were to have had two special ministry students as part of our church family - Becky Walker and Sarah Mills.

Pilgrim Lodge

In June we continued our support of this spiritual and self-discovery retreat camp on Cobbossee Lake run by the Maine Conference of the UCC by donating **\$259** to **Pilgrim Lodge**.

Our church: Stewardship for WCC 2023

It was so good to return to in-person worship this year, even though remaining limitations curtailed some activities, such as hospitality in Fellowship Hall. The month of October was spent reflecting on what church means to us and how each of us would be able to financially contribute to sustain WCC through the upcoming year, 2023. Kristin, Abe, Rebecca, and Kate shared personal testimonies. We acknowledged the painful reality of losing numerous members due to death or moving away. Despite this, 28 individuals/groups pledged to financially support WCC in 2023, at a similar \$ level.



Local missions:

Winthrop Food Pantry

We continued our longstanding support of the Winthrop Food Pantry but changed the program a little. First, we initiated an on-going collection of grocery items by placing a little red wagon in the back of the sanctuary as a repository for continuous donations of food or supplies. A monthly schedule (loosely) was set up for the youth to be included in blessing this offering and for Lee to deliver the items to the WFP. Second, in September we launched a focused drive for funds to assist the WFP in purchasing needed items for their growing customer base. Third, at year end we donated half of the funds budgeted for missions in 2022 to the WFP. In summary, WCC gave **over 100 pounds of groceries and \$1,046 to the Winthrop Food Pantry.**

Basic Essentials

Basic Essentials Hygiene Pantry is part of Bridging the Gap, a non-profit program of Augusta's Emmanuel Lutheran Episcopal Church and a Partner Program of United Way of Kennebec Valley, serving those in poverty. We re-instituted the pre-pandemic collection of soap, toothpaste, and other personal care items. Ricky and Elizabeth decorated the collection box in Sunday school. Susan Mauro, the program liaison, delivered **several boxes of hygiene products to Basic Essentials**.

Deacons' Love Fund

We donated half of the funds budgeted for missions in 2022 to the Deacons' Love Fund. Food insecurity, housing affordability and heating assistance were among the community problems the church identified through the See, Judge, Act sessions this fall. Chrissy disburses discretionary Love Fund monies to help people with such needs. We added \$88 to the Deacons Love Fund.



We supported the Family Violence Project by participating in their 2022 holiday gift program. FVP provides emergency temporary

housing for victims of domestic abuse, as well as support groups and prevention and training programs.

In November, Penny provided a beautifully decorated tree

for gifts from everyone who wished to participate during the month-long holiday collection. Gift cards and funds were also received and in December, Wendy delivered 10 bags of presents and \$355 worth of gift cards to Family Violence Project for distribution to shelter residents and other domestic abuse victims. Some of the funds for gift cards were raised by church band members Rebecca, Doug, and Jeff busking for donations at the church outdoor Christmas fair.

Board of Christian Education Report

The Christian Education Board continues with members Jill Halligan, Kristin McLaren, Carol Whittier, and Lee Wise. Jill continues to direct activities while Kristin reports to the board.

We continued with remote, asynchronous Sunday school through most of the year but made a return to in-person classes in mid-November with Covid protocols in place. We have continued to share weekly emailed Sunday School lessons from Illustrated Ministry. The Illustrated Ministry materials are aligned with the lectionary and include easy craft ideas, discussion, guided interactions with scripture and research opportunities. Lessons can be accessed at various levels and in different formats and offer an alternative to in-person Sunday school for families who attend remotely or on Sundays when it is not possible to hold class in-person.

Pastor Chrissy continues to plan engaging intergenerational services in consultation with the Christian Ed team. Intergenerational services are held in a hybrid format on the first Sunday of every month. There are no Sunday school classes on intergenerational Sundays.

To kick off the school year, a joyful blessing of the backpacks intergenerational service was held in early September. Pastor Chrissy distributed backpack blessing tags to students and teachers in-person and mailed them out to local and international destinations. Blessings were conveyed over Zoom and to all in attendance. People of all ages and occupations shared reminiscences and welcomed in the new school year. Thank you so much to Pastor Chrissy for all her hard work in preparing these wonderful intergenerational services and special events important to church members of all ages.

While in-person Sunday School classes were suspended for most of 2022, the email buddies program allowed for a meaningful way for Sunday School teachers and youth of the church to stay in touch. Youth and teachers shared surveys about their interests, favorite foods, subjects, and music, and enjoyed keeping in regular contact through this program.

While classes were on hold, the team did some reorganizing in the Sunday school rooms, cleaning out supply cupboards and materials closets. In preparation for the return to in-person classes, Carol equipped the classroom with spare masks, hand sanitizer, sanitizing wipes, and a first aid kit.

On the first day back in person in mid-November, Sunday school participants decorated the 3 C's donations box for the Basic Essentials Pantry with pictures of toothpaste, soap, and shampoo. Lessons have continued to incorporate the Illustrated Ministry materials, as well as Shine, Textweek and Godly Play. There are currently two youth who have shown interest in a confirmation class, and we are hoping to hold these classes during intergenerational services in the new year.

We continue to adapt to shifting circumstances in relation to the pandemic and to changing needs in our community and congregation. We have enjoyed finding unique and creative ways to continue with Christian Ed programming over the past year.

Hannaford Gift Card Fundraiser

Still an ongoing fundraiser for the church, entering the 13th year, Hannaford Gift Card program continues to provide a steady monthly income.

With an increase in members purchasing cards, monthly sales have been averaging \$3,000 with bonus earnings of \$150. Total annual income increased from \$1,370 in 2021 to \$1,682 in 2022.

Orders are placed monthly every 4 weeks. Members who are ordering cards will receive an email 3-4 days prior to a scheduled order date which always falls on a Monday, so cards are received by Friday.

Card payments by check are to be made out to Winthrop Congregational Church with a memo for Hannaford Gift Cards. Payment is due upon receipt of cards or dropped off at the church office beforehand.

Wider Church News

Our church is one of 147 churches which make up the Maine Conference, United Church of Christ. We have members serving the Maine Conference in various ways: Pastor Chrissy serves on the Anti-Racism Resource Team, and Hariph Smith is serving on the Board of Directors as Treasurer.

The state is divided up into seven regional Associations. We are part of the Living Water Association which includes 17 churches from Weld to Pittsfield and Monmouth to Jackman. The Association meets each Spring and Fall.

There have been many changes in Conference Staff over the last few years. The Rev. Jonna Jensen completed her term as the Transitional Conference Minister. In October, Rev. Dr. Marisa Laviola began her term as our next Conference Minister. Rev. Alexis Fuller-Wright continues as Associate Conference Minister. Also, Liz Charles McGough began her first year as the Director of Pilgrim Lodge.

The Spring Association meeting was held on May 15th as a hybrid meeting online and in Winslow. Pastor Christina Cataldo, Dina Blodgett and Sandra Smith represented our church. Our Pastoral Intern Sarah Mills attended as well. After a little bit of a rough start due to internet stability issues, we were able to tend to the business of the wider church though the pre-recorded worship elements Rev. Ian developed just wouldn't work.

Also, Rev. Mo Ausbrook, who is a member of Waterville UCC, gave a presentation about Starfish Village (https://www.watervilleucc.org/starfish-village), their ministry which focuses on families and individuals experiencing homelessness and poverty.

The Fall Association meeting was cancelled and a Service of Closure was held on Oct 30th for the New Sharon church as they decided to close their doors. Pastor Chrissy Cataldo attended this service, which was held at Shorey Chapel in Industry. It was a deeply meaningful and gracious service, with current and former members and pastors of the New Sharon church lifting up stories of the life of that congregation. It ended up

being one of the first services Rev. Dr. Laviola attended in her role as Conference Minister.

The Maine Conference of the UCC, held two Special Meetings plus the Annual Meeting.

The first Special Meeting was held August 6th to call the Rev. Dr. Marisa Laviola as our next Conference Minister. Pastor Chrissy attended along with delegates Sandra Smith and Dina Blodgett.

The second Special Meeting was held via zoom December 4th to approve the Clergy Compensation Guidelines. Pastor Chrissy attended along with delegates Connie Mayette and Kristin McLaren.

The Annual Meeting of the Maine Conference was held on Sat, October 15th via Zoom. Pastor Chrissy represented the church along with delegates Cyndi and Dana Hall. Hariph Smith attended as Conference Treasurer. The theme was "Where the River Flows, Life will Flourish".

The music was lovely, with musical offerings from several churches across the conference, including the Pilgrim Lodge Family Camp Choir. Congregations shared testimonies about how ministry is going as well go into the third year of a pandemic. Action was taken to approve a Resolution of Support for Tribal Sovereignty in Maine.

Thank you to WCC, UCC for supporting Winthrop's involvement in the Wider Church through our connections with the Living Water Association and the Maine Conference.

Fish Chowder Luncheon Report

As with most activities involving crowds and public access, our luncheons were cancelled as of March 2020 due to gathering restrictions during this pandemic.

There has been some discussion about bringing back this popular 46-year tradition of holding luncheons on the second Friday on the month for eight months out of the year. The fundraiser brought in over \$3,000 each year and provided a community gathering spot for many of the attendees.

However, we have had many changes in our membership, with folks relocating, changing jobs, folks experiencing health issues, and changes in living arrangements. These factors affect our capacity to host larger events. After brainstorming some on fundraising ideas, we decided to offer ready-to-heat pints of fish chowder at a simplified Outdoor Christmas Fair. That idea turned out to be a fun and different way to have fish chowder with fewer volunteers, a good compromise for the situation.

Ad Hoc Fundraising Committee Report

In the last quarter of 2022, when it appeared that the church might exceed their targeted budget deficit, a small group of members thought there might be an opportunity to do additional fundraising. Church members forwarded several fundraising suggestions. One of which was to have an outside, simplified Christmas Fair. Through the efforts of many people \$1,478 in net proceeds was raised, the community enjoyed the church band playing, and a sense of church and community fellowship was felt by all. New Directions Report

On Mar 13th, a zoom meeting was held to discuss CWS kits and the year's schedule. The group suggested that we hold quarterly meetings and periodic socials (instead of bi-monthly meetings and socials on alternating months as originally planned).

New Directions coordinated the collection and delivery of CWS Material Aid Kits. Ann,



Carol W, Carol E, Lee, Ginger & Hariph assembled the kits on Apr 25th. On May 4th, Dana & I delivered 12 school bags and 25 hygiene kits to Maine's collection point at Woodfords Congregational Church. Church World Service will distribute these kits to disaster relief areas.

Special thanks to Pat & Glenn Goff for their generous donation towards the shipping & handling of the kits and many thanks to those who donated items for the kits!



We held three socials this year:

After worship on May 1st eleven of us enjoyed a lovely brunch at Willows Awake Winery in Leeds. Fifteen of us attend the Addams Family musical at Cumston Hall. How wonderful it was to gather for good food and conversation and to enjoy a show with talented performers and wacky humor.

On June 5th, eighteen people enjoyed a lunch after worship at the Weathervane in Readfield. The newly remodeled downstairs dining area was perfect for conversation and fellowship and the food was superb!

The summer social planned for July 17th at Kate Goodspeed's place had to be cancelled as Kate fell, leaving her sore and bruised with broken ribs. Kate will likely reschedule this day of fun in 2023!

On Nov 6th, seventeen people attended the matinee performance of "Clue, The Musical" in Auburn. The Monmouth Community Players acted out scenes which incriminated ALL of the Clue characters, so the mystery was tough to solve! Eight of us went to the Lotus Restaurant in Auburn beforehand.

Joan Edwards continues to spread good cheer with "Sunshine" Cards, often hand made. Thank you, Joan, for your gift of time and care. New Directions presented prayer shawls to Jen Phillips and Lee Wise as they faced health issues.

New Directions sold RADA Cutlery, scrubbies, dishcloths, and grape jelly, at the Summerfest in August and dishcloths at the outdoor simplified Christmas Fair. RADA prices have increased so much that we will stop selling RADA Cutlery once our inventory is depleted. These funds are used to purchase paper towels and toilet paper for the church.

In the past, this group has hosted receptions after funeral services, but we didn't serve in this capacity this year. We continue to collect donations of loose coins to support our Altar Flower Fund. We also received a generous donation from Jane Wylie for the Flower Fund in memory of her parents Mary & Hilton Twombly and spouse Neil.

At Christmas time, Longfellow's Greenhouse donated 10 beautiful poinsettias, which decorated the Sanctuary and were distributed to people in our church family to help perk up their spirits.

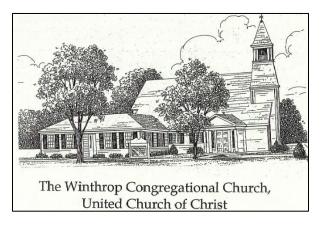

Historical Records Committee Report

In 2015 and 2016, our Historical Records Committee (consisting of Marie Hatfield, Cyndi Hall, Margaret Imber, Marie Pettengill, Ann Mitchell, and Sandra Smith) made a great deal of progress going through our historical records and creating an inventory from 1776 onward. We also spent numerous hours at the Maine State Library (MSL) scanning historical records. Adam Fisher, the Director of Collections, was extremely helpful in getting our digitized records on their Digitize Maine Repository and can be viewed online. Check it out at https://library.digitalmaine.org/.

Based on information provided by the Congregational Library and Archives (CLA) in Boston, CLA recommends that churches write Record Management Policies, specific guidelines of what documents to preserve for historical purposes, such as Annual Reports, newsletters, membership lists, clerk records, etc. Once a policy is in place, the committee needs to set aside time to update and preserve these files on an annual basis (CLA website https://trello.com/b/IF7qadSP/church-stewardship-resources). I am willing to serve on the committee but cannot do it alone. Anyone else interested in serving on this committee?

"See. Judge. Act." Report

At the encouragement of the Board of Church and Community Concerns, the church has begun a mission discernment process called See. Judge. Act. This process involves inviting regular attendees of the church to come together to identify needs they see in the community, then discern which needs the people of the church have the most energy to address. And, finally, to invite interested and excited people to begin to figure out how we might act together to address the issues. The hope is that we can also invite community members outside of the church to join with us in our actions.

This fall, we had our initial See and Judge sessions. Included below is a report drawn up by Kate Goodspeed of needs that church members believed were of sufficient interest to begin working on developing some actions. They are really promising. Now that we have gotten through some of the busy fall, with stewardship and budget development done, it might be a good time to return to this list of potential community needs that we feel called to address. Do you feel the spirit calling you to address any of these community needs and invite others along with you?

Judge and Act Report Out.....

On October 16th, 16 church folk, including 1 family with children, gathered to brainstorm in the Judge and Act phases. Guided by Pastor Chrissy, we listened to 2 portions of the Bible: Luke 4 16-20 and Matthew 25: 31-42.

Gathered around 2 round tables, we looked at all the ideas generated by the See activity in September and discussed what types of actions we are called to by these teachings of Jesus. In the face of so many issues raised in September, we narrowed it down to two areas that seemed to fit with our congregation: Food Security and Influencing the Community. A possible third area needs more research: Safe Space for Youth, especially GLBTQ youth... Is there a need for this in Winthrop?

Food Security

Some of the ways we most enjoy ourselves as a community revolves around food, making it, sharing it, eating it!

What are the gaps in providing food and meals to those who need them in Winthrop? We liked the name of one program advertised as Friends, Fun, and Free Food. Fish Chowder was mentioned. We could reach out to Joellen Cotrell at the Food Pantry, and folks at St. Francis Xavier who provide free meals currently, and look at other models, such as the work of the youth at Old South Farmington. We could make a list of existing programs and, working with others in Winthrop, determine the gaps and how our church could fill them.

Interested in working on this issue were: Kate, Rebecca, Carol Whittier, Maryelise, and Ann Mitchell.

Influencing the Community

Many of the issues raised in September involve international, national, regional and local problems. We must be willing to speak out, individually with the support of our community, and take the first step in advocacy.

How can you make your voice heard? Possibly a workshop for children, youth, and adults on how to influence others and make your voice heard. Folks could be empowered to help us, as a church community, support these efforts. For example, the need for affordable housing may not be something we can resolve directly, but we can support the efforts and possible legislation that would help solve the problem. Tribal Sovereignty, assault rifles, global warming, vaping and smoking around schools are other issues that could be looked at.

Patrice and Kate were interested in this issue, but would welcome others to join them. Young folks?

What can you do? Join us in these explorations by emailing or calling the office or speak to Pastor Chrissy. Look for opportunities to take action as they are reported out in the following months.

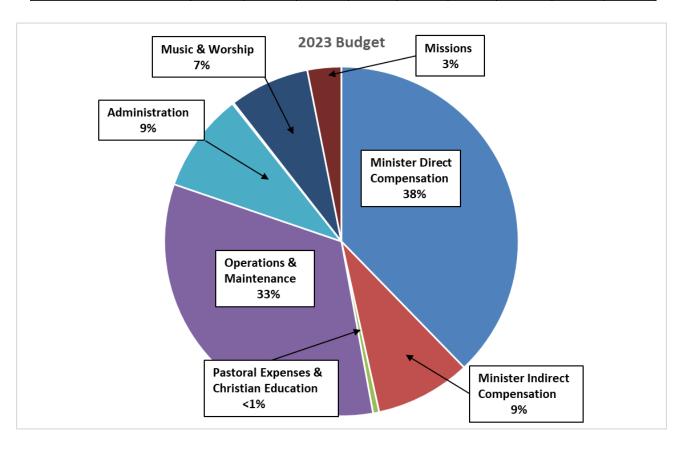

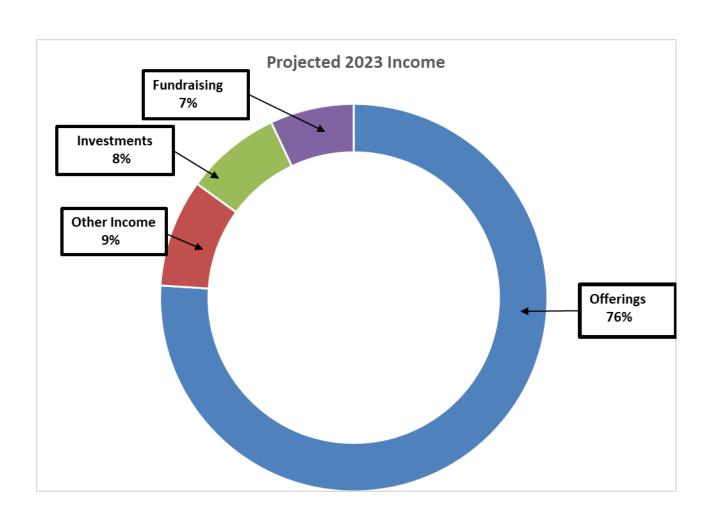
